HEALTHY CHURCH PLANTING Module 1

Learning Objective: Participants will be able to tell in their own words

- » What a healthy church is;
- » Why planting a healthy church is important; and
- » The basic process of planting a healthy church

Introduction to Module 1

Facilitator Introductory Remarks (2 min.)

- Welcome participants in a warm, friendly, and enthusiastic manner.
- Lead participants in a brief prayer together, dedicating the day to the glory of God.

Getting to know you activity (5 min.): Three Words

Facilitator Instructions:

- Ask the participants to think of three words that describe themselves.
- Tell the participants how many people are in the group and that they have 4 minutes to shake hands with everyone in the room, introduce themselves, and share their three words.
- At the end, see how many people actually made it to everyone in the room. You may want to ask for the number of people they interacted with. For example, if there are 20 participants: How many shared with 10 people or more, 15 people, 20 people? Celebrate and enjoy the moment.

Example:

Hi, my name is Mary. I would describe myself as curious, kind, and hard-working.

Facilitator Instructions: The purpose of this activity is to help participants establish an immediate focus on the knowledge, skills, and attitudes that are required for planting a healthy church.

- Say, "Each of you brings a wealth of experience with churches to your church planter training. The focus of this module is to help you describe the characteristics of a healthy church and what it takes to plant a healthy church."
- Divide the large group into 2 smaller groups. Within 4 minutes, ask Group A to list as many characteristics of a healthy church they can think of based on their experience. Likewise, ask Group B to list as many characteristics of an unhealthy church they can think of based on their experience.
- Allow each group 1 minute to report its list of characteristics.
- Say, "Today we will be learning about the 10 characteristics that Multiplication Network Ministries finds to be the essential characteristics of a healthy church. However, first we are going to consider together five biblical reasons for planting a healthy church."



BIBLICAL FOUNDATIONS FOR HEALTHY CHURCHES (15 MIN.)

Opening Activity (2 min.)

Facilitator Instructions: Ask participants to share their thoughts on reasons for planting new churches. Ask them to listen to see which of these are mentioned in this session.

Assign the Bible passages for each biblical reason to different participants. Ask them to read the Bible passages aloud to the group. Lead the group to discover each biblical reason from the passages read and fill in the corresponding blank spaces in their workbooks.



Devotional Bible Study (13 min.)

There are five biblical reasons for planting new healthy churches:

1. Because God is the <u>Father</u> who <u>seeks</u> and <u>finds</u> the lost. Key verses | Genesis 3:9; Psalm 23; Luke 14:15-24

2. Because <u>Christ's</u> love compels us. Key verses | 2 Corinthians 5:14-20; Matthew 18:12-14; John 14:23

3. Because the Holy Spirit has been sent to all people. Key verses | Acts 2:5-11; 10:44-48; 1:8

4. Because the local church is a <u>branch</u> of the <u>Kingdom</u> of God. Key verses | 1 Peter 2:5, 9-10, 12; Colossians 1:13-23; Romans 12:4-8

5. Because planting new churches brings glory to God. Key verses | Ephesians 1:1-14; Revelation 7:9-12

- Explain how to fill out the form.

WHAT IS A HEALTHY CHURCH? (60 MIN.)

CASE STUDY: STORY OF AN UNHEALTHY CHURCH (10 MIN.)

Facilitator Instructions: The case study leads participants to experience a real-life problem situation so the participant gains an understanding of the 10 characteristics of a healthy church. The case study begins by describing an unhealthy church, specifically a church that was planted in an unhealthy manner.

- Ask participants to read the "Story of an Unhealthy Church."
- Ask participants to describe some of the specific indicators of the church's unhealthy condition.
- Discuss with participants how these indicators relate to 5 Steps of Planting a Church.
- Ask, "When did this church start becoming an unhealthy church?" Participants should recognize that the church was on an unhealthy path from the time it was planted.
- Say, "The purpose of this session is that you gain an understanding of the importance of the 10 Characteristics of a Healthy Church so that you will build them into your new church as you plant it. Unlike the Hosanna Church, your new church will be off to a healthy start!"

Story of an Unhealthy Church

When Hosanna Church was first planted, it began with conflicts and hurts. According to the church's history, the decision to plant Hosanna Church came from conflicts between one faction of a congregation who respected its retired senior pastor and another faction loyal to the current senior pastor. Finally, the denomination decided to separate the congregation into two churches. One of the new congregations, over time, took the name Hosanna Church. Pastor Lee was chosen to be the first senior pastor of one of the new congregations. Quickly he encountered conflicts with church elders who then left the church with some members.



In this church, every elder was over 55 years old. Both young adults and youth had a strong distrust of the church leadership. This distrust was one reason why the Hosanna Church separated from the former congregation. Hosanna Church did not easily accept changes in the direction of revitalization. As the composition of the church membership aged, Hosanna Church found it even more difficult to make the necessary changes to be a vital congregation.

The traditional worship style was a big problem, because only the older church members appreciated it. The sanctuary had a capacity of about 1,000 attendees, but Sunday worship service attendance averaged 200 worshippers. These problems were the tip of the iceberg.

The church's financial condition was bad. In winter, they did not use the heater because of the church's poor financial condition. During summers there was the same problem regarding the air conditioner. The church was in debt. What was worse, the church leadership did not commit to tithe. Follow-up systems for converts were nonexistent. Small groups were just formal groups for women and other small groups for church members. These groups were not reproducing through evangelism. Continual troubles, separation, and unfaithfulness to each other were the substance of Hosanna Church. This summarizes the sad condition of Hosanna Church before it entered into a revitalization process to regain its health.



10 CHARACTERISTICS OF A HEALTHY CHURCH (5 MIN.)

Facilitator Instructions:

- Lead participants to fill in the following graphic as you discuss each topic.
- Also, ask participants to take notes in their workbooks.

Say, "The 10 Characteristics consist of five elements and five functions." Ask participants to fill in the five elements and five functions in the places provided in the graphic.

Say, "Let's begin with the five elements." Ask participants to fill in the graphic and take notes in the spaces provided as you share this information in lecture format.

FIVE ELEMENTS OF A HEALTHY CHURCH (20 MIN.)

1.- CLEAR VISION

Definition: Having vision means looking toward the future to <u>see</u> in a clear mental picture what <u>God</u> wants to do <u>through</u> you to achieve His <u>redemptive purposes</u>.

"The church sees clearly what God wants it to be and do, so that the Body of Christ will serve to reflect his new creation in the community."

What does <u>God</u> want the church you are planting to be and to do? During your training, you will write a vision statement that summarizes what God is calling you to be and do as a church. Use this to stay focused in your ministry.

2.- EMPOWERING LEADERSHIP

Definition: Christian leadership can be defined in the following way: "Christian leaders are people committed to <u>God</u> (character), who know <u>where</u> they're going (vision) and who have <u>followers</u> (influence)."

"The church is served by people who understand its vision, can communicate it clearly to the congregation, and can organize the Body of Christ to make the vision a reality."

Say, "Let's look briefly at how Paul developed and empowered the leaders."



• Have someone read 2 Timothy 2:2.

Say, "For Paul, developing the leadership of each local church was crucial so that the church would endure. This is what he did:"

A. He gave the leaders <u>space</u>. He put them in <u>charge</u> of the work.

- B. He was committed to preparing them.
- C. He trusted them.

3.- MOBILIZED BODY

Definition: Church members work together using their <u>gifts</u> responsibly in the <u>congregation</u> and in the <u>community</u>. "Each one should use whatever gift he has received to serve others, faithfully administering God's grace in its various forms. If anyone speaks, he should do it as one speaking the very words of God. If anyone serves, he should do it with the strength God provides, so that in all things God may be praised through Jesus Christ. To him be the glory and the power for ever and ever. Amen." I Peter 4:10-11

Five Practical Steps to Mobilizing Members:

I. Prepare your leadership to mobilize the entire <u>congregation</u>.

II. Teach about <u>spiritual gifts</u> and the stewardship of <u>talents</u>.III. Identify the <u>gifts</u> and the areas of <u>interest</u> of each believer in the congregation.

IV. Ask each member to work in a <u>ministry</u> or area of <u>service</u>.V. Keep an eye on <u>how</u> the different areas of church life are going and make the necessary <u>adjustments</u>.

4.- STEWARDSHIP OF RESOURCES

Definition: The Church challenges its members to be good <u>stewards</u> of their <u>possessions</u>, their <u>resources</u> and their <u>goods</u>. Stewardship is using these material and financial gifts to accomplish the work of the kingdom of God in the <u>church</u> and in its <u>community</u>.



"Honor the LORD with your wealth, with the first fruits of all your crops; then your barns will be filled to overflowing, and your vats will brim over with new wine." Proverbs 3:9-10

5.-CONNECTION BETWEEN THE TEXT AND THE CONTEXT

Definition: A healthy church takes into account its context (geographic location, social and economic factors, cultures, etc.). While the <u>message</u> of the good news in Jesus Christ does not change, the <u>methods</u> for sharing it do.



"All Scripture is God-breathed and is useful for teaching, rebuking, correcting, and training in righteousness, so that the servant of God may be thoroughly equipped for every good work." 2 Timothy 3:16-17

FIVE FUNCTIONS OF A HEALTHY CHURCH (15 MIN.)

1.- EVANGELISM

Definition: The Church <u>announces</u> the Good News of Jesus Christ in <u>word</u> and <u>deed</u> and <u>invites</u> people to be part of the Kingdom of God. Acts 1:8

"And the Lord added to their number daily those who were being saved." Acts 2:47

2.- DISCIPLESHIP

Definition: The Church helps people to see <u>God</u> more clearly, get to know his <u>will</u> for their lives, and <u>equip</u> them to follow him in <u>all</u> aspects of life. 2 Peter 3:18

"They devoted themselves to the apostles' teaching..." Acts 2:42

The four C's of discipleship:

<u>CONDUCT</u>
 <u>CHARACTER</u>
 <u>CONTENT</u> of the gospel
 <u>COMMITMENT</u>

3.- <u>SERVICE</u>

serving others.

Definition: The Church addresses the <u>needs</u> of people in the <u>name</u> of Christ and <u>invites</u> them to be his <u>disciples</u>.

"Selling their possessions and goods, they gave to anyone as he had need...enjoying the favor of all the people..."Acts 2:4 5, 47

Three Types of Relationships between Service and Evangelism

I. Ministry as a <u>RESULT</u> of evangelism: Conversion to Christ makes us attentive and eager to meet the needs of others.

II. Ministry as a <u>BRIDGE</u> for evangelism: Service to others as the starting point that later makes them willing to hear the gospel.
III. Ministry <u>ACCOMPANYING</u> evangelism: speaking of Jesus while

4.- FELLOWSHIP

Definition: Members help carry each other's <u>burdens</u>, showing the <u>love</u> and <u>compassion</u> of Christ.



"They devoted themselves... to the fellowship... All the believers were together and had everything in common... Every day they continued to meet together with glad and sincere hearts..." Acts 2:42, 44, 46

5.- WORSHIP

Definition: The Church gathers as the <u>family</u> of God to meet with the Father in <u>worship</u>, <u>confession</u> and <u>gratitude</u>, as well as dedicating themselves to <u>service</u> and <u>prayer</u>.

"They devoted themselves... to the breaking of bread and to prayer... praising God..." Acts 2: 42, 47



Small Group Activity: I Remember When . . . (10 min.)

Note to Facilitator: The purpose of this activity is to provide participants with the opportunity to reflect on previous experiences and compare them to new learning.

Facilitator Instructions:

 Divide the large group into smaller groups of 3 or 4 people each. Ask each person in the small group to share a personal experience with a characteristic of a healthy or unhealthy church. Ask each person in the group to complete these phrases: I remember when [name the experience] happened; it made me feel [name the emotion], so I [name an action taken because of the experience], because [why you took the action].

Healthy Church experience example: I remember when my pastor took time to disciple me; it made me feel like I was important to him and to the church, so I volunteered to teach a new members class because I wanted our new members to know they, too, are important to the church. Facilitator Instructions:

- After everyone in the group has shared their experience, have the groups discuss how their experiences relate to the 10 Characteristics of a Healthy Church they have just learned.
- Finally, close the session by saying, "In the 12 modules of this training, you will learn how to apply each of these 10 Characteristics in your work as a church planter so that in the end we will celebrate together the birth of a new healthy church!"





Session 3

"Z" THINKING: What Does God Want? (60 min.)



WHAT IS " Z" THINKING? (10 MIN.)

Facilitator Instructions: Say, "What is 'Z' Thinking?"

"Z" is the <u>end result</u> of what God ultimately wants for a nation, region, city, village, or neighborhood. "Z" is used because it is at the end of the English alphabet–the final or ultimate letter, just as Omega ends the Greek alphabet.

Facilitator Instructions:

• Ask various participants to read and reflect on the scriptures and questions provided.

Read:

Isaiah 11:9; 65:12-25; Revelation 21:1-4, 22-27; 22:1-5

Reflect:

- How do these texts describe the "end-game" (the ultimate end that God wants)?
- What is the danger of only focusing on heaven and not on the new earth?

- What do these verses tell us about God's plan for reaching out with the gospel?
- What are some of the ways God achieves His desired end result?
- What is the number one instrument that God uses in achieving His desired end result?



• Is there another means God is using more effectively today?

Read:

Matthew 28:18-20 Acts 1:8 Ephesians 3:10

Reflect:

• What do these verses tell us about our work in fulfilling God's desire for the world?

Some Essential Steps to Get to "Z" (15 min.)



Facilitator Instructions:

- Divide participants into groups of 3 or 4.
- Ask individuals in each group to read aloud the Scriptures associated with each of the following 5 topics and discuss the related question in their group.
- After 10 minutes of group work, give each group one minute to share briefly the important points they discussed.



A. Prayer 2 Chronicles 7:14, Matthew 9:38 What should we pray for in our quest to achieve "Z"?

B. Love and Unity | John 13:35, John 17:20-23 Why is love and unity essential to achieving "Z"?

C. Vision | John 3:16, 1 John 2:2, Matthew 9:37 What do these verses tell us about God's vision?

D. Evangelism | Romans 10:14-15

How can we find opportunities to witness to unbelievers in our area? How do believers reach beyond their circle of other believing friends to unbelievers?

E. Church Planting | Ephesians 3:8-11, Ephesians 4:11-13

What does God want his people to be doing? When a new church is planted, people are reached in the surrounding neighborhood that would not have been reached with the gospel without a new church. What are some reasons this happens? If you know of a case of this occurring, tell the group about it and discuss what happened.

"Z" THINKING RESULTS IN "Z" ACTION (10 MIN.)



Facilitator Instructions: Say, "Two actions that result from 'Z' thinking are 'Z' <u>planning</u> and 'Z' <u>giving</u>." Briefly discuss the following questions.

1. What are some strategic questions that must be answered for church planting to occur?

2. What are some plans that need to be made as a church progresses toward planting a new church?

ACTION PLAN FOR MODULE 2: YOUR "Z" PLAN (15 MIN.)



Facilitator Instructions:

- Read through the following assignment with participants.
- Point out that the results of this assignment will be shared with the group in Module 2.
- Take time to answer all questions about the assignment.

- Ask participants to read 2 Corinthians 8:7; 2 Corinthians 9:6-7.
- Discuss the following question.

Facilitator Instructions:

- Share the following principles related to financing a church plant and ways to find funds for planting a church.
- Ask participants to fill out the appropriate spaces in their workbooks.

Say, "There are two important concepts regarding funding a church plant."

1. <u>Trust God</u>

2. <u>Contentment</u>

Facilitator Instructions:

- Ask participants to read Philippians 4:6-7; 11-13, 19 and briefly discuss their relationship to these two principles.
- Then share with the class the following ways to fund a church plant.




Session 4

Facilitator Instructions: Using the Church Planting Cycle graphic below, give a brief overview of the cycle of church planting.

THE CHURCH PLANTING CYCLE (5 MIN.)



Small Group Activity (25 min.)



- Facilitator Instructions:
 - Divide into 7 groups (1 group for each phase). Assign a phase to each group.
 - Ask the groups to read aloud the Bible passages associated with their phase.
 - Instruct the group to develop as many actions as possible to address the "Activities" and "Key Issues" associated with each phase.

PHASE I: PRAYER (Luke 10:2, Ephesians 6:18-19, Colossians. 4:2-4) ACTIVITIES:

- Begin with prayer.
- Locate the group with whom you will do evangelism and church planting.
- Pray for those who will help and for yourself.

KEY ISSUES

- What is my personal harvest field? What does God want from me in my area?
- What are things about the calling and vision that God is giving me that are different from those He is giving other people?
- Who is going to help?
- Who should I pray for? What should I pray for?
- What should I ask God to do in my own service to him?

PHASE II: EVANGELIZE (1 Corinthians 9:19-23; Acts 1:8) ACTIVITIES:

- Contact key leaders and build relationships.
- Evangelize the lost.
- Start evangelistic group Bible studies.
- Show the new believers how to do ministry by the way you do it.

KEY ISSUES:

- What evangelistic methods are most effective for us to reach our goals?
- How do we make contacts with key leaders? Who are they?
- How do we find them?
- How do we train new believers to be witnesses to their friends and family?
- How do we find out who the friends of the new believers are and begin evangelizing them?

PHASEIII: MAKE DISCIPLES (1Thessalonians 5:11; Matthew 28:18-20) ACTIVITIES:

- Disciple new believers.
- Mentor emerging leaders.

- Teach obedience and commitment to the Lord.
- Encourage believers to become like Christ.
- Teach new believers to obey Christ.

KEY ISSUES:

- How to develop and disciple a group of people?
- How to model effective leadership?

PHASE IV: GATHER TOGETHER (Hebrews 10:24-25)

ACTIVITIES:

- Expand evangelism efforts through the network of friends.
- Multiply cell groups by having each cell group work toward starting other groups.
- Begin ongoing regular worship.

KEY ISSUES:

- How will new cell group leaders be trained and released?
- When do we baptize new believers? When and who gives them communion?
- How will we establish a close fellowship of believers? How will new believers be brought into the fellowship?
- When we gather, where do we meet? How do we invite people?
- What forms will we use to reach our intended purpose?
- What style of worship will we use?

PHASE V: DEVELOP LEADERS (2 Timothy 2:2)

ACTIVITIES:

- Build a profile of leaders needed in each area of ministry.
- Find and write down the spiritual gifts of all members.
- Train cell group leaders.
- Assign and release leaders to ministry.
- Organize the structure and ministry positions you envision for the ministry.
- Follow-up with leaders to provide support.

KEY ISSUES

- How do we get new believers to discover their spiritual gifts? Who will train them?
- What are the areas of training that are needed? Where and how

will this training be provided?

- Who are the potential key leaders? What are their gifts and abilities? Are they faithful, serving people?
- Where will those trained have a ministry? What are the basic needs and issues in that area? When will their ministry in that area begin? To whom will they report? What is their job description?

PHASE VI: MULTIPLY (Acts 1:8)

ACTIVITIES:

- Coach leaders to form church planting teams.
- Train workers for several different kinds of ministries involved in church planting.
- Research new regions where people feel led to start ministry.
- Plan and conduct evangelistic efforts in new regions.
- Establish and appoint leaders for the ministry who will work with us.

KEY ISSUES:

- What research needs to be done? Who will do it? Are there people groups nearby that are still unreached with the gospel? Are there potential leaders among them who can be trained?
- What goals need to be set and made available to the appropriate persons? Who is heading up the prayer effort to support this ministry?
- Who assigns and oversees all new church planting ministries?
- Do we need any additional training ministries to train different levels of leadership for this movement? Who will do the training? How will it be financed?

PHASE VII: MOVEMENT (Isaiah 11:9)

ACTIVITIES:

- Cover all people groups of the country.
- Establish guidelines for the increase of the movement.
- Determine cross-cultural mission projects the groups will sponsor.
- Conduct prayer and praise rallies.
- Set regional and/or national goals.

• Establish higher levels of training for key leaders of the movement.

KEY ISSUES:

- Is the movement self-developing, self-supporting, and selfgoverning? If not, what needs to be done to make sure that it is?
- What regions or peoples are still unreached? What mission projects is the Lord leading us to initiate?
- What kinds of training are needed for the movement? How will it be supported?
- Who are the "apostle-type" leaders for the movement? How can we work together with them? How can we encourage and support them? What are their needs?



Large Group Reporting (30 min.) Facilitator Instructions:

• Allow each small group 5 minutes to present their ideas for action related to their assigned phase to the large group.

WHY Small Groups? (60 min.)

BIBLICAL FOUNDATIONS OF SMALL GROUPS (5 MIN.)

Facilitator Instructions: Say, "The use of small Bible study groups for evangelism and discipleship is central to the method of planting healthy churches taught in this course. In some church planting courses, a difference is made between the terms 'cell group' and 'small group.' In this course, we will use the term 'small group' but consider it the same thing as a 'cell group.'"

We define a small group (or cell group) as a small group of individuals that gathers to <u>study</u> <u>God's</u> <u>Word</u> for the purposes of <u>evangelism</u>, <u>discipleship</u>, and <u>service</u>, contributing to the formation of a <u>healthy</u>, <u>worshiping</u>, new church.

Facilitator Instructions:

- Ask the large group the following questions:
 - 1. Were there groups like those we call small groups in the New Testament Church?
 - 2. What are the things that make a Christian small group different from other groups?

Small Group Bible Discovery Activity (15 min.)



- Facilitator Instructions:
 - Divide into 4 groups.
 - Assign each group a question and the indicated Bible texts.
 - Ask the group to read the Bible passages, to answer their question, and to prepare to report their answer briefly to the large group.
 - Ask all the groups to work in the same room.
 - Note that each group will have 10 minutes to complete this activity.
 - After 10 minutes (without reforming the large group), ask each

Group B: What are the benefits of small groups for discipleship? What are some possible activities of small groups that might result in helping, teaching, and mentoring?

Group C: What are the benefits of small groups for fellowship? What are some possible activities of small groups that might produce mutual encouragement, sharing, and friendship in Christ?

Group D: What are the benefits of small groups for worship? What are some possible activities of small groups that might praise

and glorify God?



Large Group Reporting and Discussion

Facilitator Instructions:

- Ask each small group to report briefly on how it answered its questions. (10 min.)
- To close the session, lead the groups in a discussion of the following questions: (10 min.)

 What are the benefits of small groups for developing leaders?
 Based on all we have learned in this session, how do you summarize the benefits of small groups for church planting?

Session 6

LETTING THE BIBLE TEACH US (60 min.)

INDUCTIVE BIBLE STUDY METHODS, PART 1

Inductive vs. Deductive (2 Tim. 2:15) (10 min.)

Facilitator Instructions: Using the outline below, explain the difference between an inductive and deductive approach to Bible study.



1. The Deductive Approach

I. Deductive Reasoning

We <u>begin</u> with a known and accepted idea and take from it ("deduce") a <u>conclusion</u>.

II. Deductive Bible Study

The teacher states a general rule that in the New Testament, yeast (or leaven) many times refers to sin. When we read Matthew 13:33, we assume that yeast refers to sin. Read the passage. Does yeast refer to sin here?

III. A "Typical" Method

Bible teachers often know what they want to say, and simply come to the Bible to find a verse that seems to support their understanding. Why would this create a danger for misunderstanding the true meaning of the passage?

2. The Inductive Approach

I. Inductive Reasoning

We <u>examine</u> the facts closely in order to try to understand what the facts mean.

II. Inductive Bible Study

We carefully examine the <u>text</u> and <u>context</u> of Matthew 13:33 to determine what the word "yeast" or "leaven" is referring to.

III. Inductive is a Better Method

When helping people discover the truths of the Bible as they study, the inductive method is a good choice.

STEPS OF INDUCTIVE BIBLE STUDY (20 MIN.)

Facilitator Instructions: Ask participants to complete the following outline in their workbooks as you share the missing words.

- A. <u>Observation</u> What does it say?
- B. Interpretation What does it mean?
- C. <u>Application</u> What should I do?

TIPS FOR INDUCTIVE BIBLE STUDY

Build a solid foundation. This begins with thorough <u>observation</u>. Carefully examine the content of the passage to determine its true meaning so that one can make a valid application.

Take adequate <u>time</u> for the study. Do not rush by beginning with a quick reading and assuming that you know what it means. Do not make a hasty and questionable application of what it teaches.

Facilitator Instructions: At this point, ask participants if they have questions about the inductive method of Bible study. Take time to respond adequately to their questions.



A MODEL INDUCTIVE BIBLE STUDY (25 MIN.)

Facilitator Instructions: Lead the class in a brief inductive Bible study of John 1: 1-5. Be sure to encourage participation in the process. Ask participants to take notes on the passage in the outline provided in their workbooks.
